### A LETTER FROM THE EXECUTIVE DIRECTOR & BOARD CHAIR

As I reflect on the past year, I can't help but feel overwhelming gratitude for everyone in the CLA community. The dedication and commitment of our staff, board, volunteers, partners and donors has helped us grow and flourish over the past year. 2022 brought tremendous growth, maturity and innovation. We have increased our services and donors, we have created strategic partnerships to reach and serve more in our community and we have continued to bridge the gaps in services to ensure that everyone in our community has access to quality legal representation. I could not be prouder to share with you our accomplishments in 2022:

- We were awarded an Equal Justice Works Housing Justice Fellow and hired a full-time attorney fellow to increase direct representation to tenants and expand Housing Court in Berkeley and Dorchester Counties.
- We continued to expand our family law practice and assisted 161 families with their family law matters, a 9% increase from last year.
- We prioritized cases for victims of domestic violence and partnered with My Sister's House and SCCADVASA to offer legal office hours to victims of domestic violence to ensure that survivors have meaningful access to counsel. Through this partnership, we assisted 28 victims of domestic violence.
- We continued to partner with HALOS to provide legal assistance to kinship care providers seeking custody. In total, we have provided legal assistance to 25 kinship care families.
- We closed 357 matters increasing the number of families served by 109% from the previous year.

Before CLA, Lowcountry residents had no options for attorney access if they fell into the justice gap between free legal services and the private legal market. Our success to date, demonstrates the demand for quality and affordable legal representation. We have stayed at capacity since opening our doors in 2016 and the demand for our services has only continued to grow year after year. In 2022, CLA saw a 35% increase in incoming calls seeking our services.

We know there is a large and persistent need for CLA's services and with the help of committed partners and supporters like you, we will continue to innovate and work hard to make sure that every South Carolinian has access to meaningful legal representation.

I am proud to share the impact of your investment in your community. Thank you for taking this journey with us and helping to expand access to justice in the Lowcountry.

### ABOUT CHARLESTON LEGAL ACCESS

Charleston Legal Access is South Carolina's first sliding-scale nonprofit law firm dedicated to expanding access to legal services and rights in the Lowcountry. We provide low-cost legal representation and assistance to individuals and families with low to moderate incomes who do not qualify for free legal aid but who cannot afford a private attorney. Our costs are calculated on a sliding scale to help everyone who needs representation get a lawyer at a cost that won't break the bank.

64.4% of South Carolinians fall below 400% of the Federal Poverty Line.

### WHO WE SERVE

We serve those who do not qualify for free legal aid and cannot afford a private attorney.

Free legal aid is capped at 200% of the Federal Poverty Line. For a single person, the gross income limit is just \$29,160. For a family of four, the household income limit is just \$60,000.

We serve individuals and families that fall below 400% of the Federal Poverty Line residing in Berkeley, Charleston, and Dorchester counties.

# SERVICES

Our services include:

- advice and counsel sessions over the phone for free
- 1-2 hour in-depth, in-person consultations for a flat fee
- full legal representation on a sliding scale

#### Our sliding scale model provides legal assistance at low, accessible rates of \$50 - \$100 per hour.

Rates are determined by income and family size. We handle a variety of civil matters including:

- Civil Rights
- Contract/Tort Litigation
- Consumer Issues
- Elder Abuse & Financial Exploitation
- Family Law
- Housing
- Probate
- Property
- Simple Wills & Power of Attorneys
- Victims Rights
- Wage Theft



Mr. M came to CLA after he had provided construction work and materials to a general contractor who then refused to pay him for his work. Mr M. did not speak English and felt that part of the reason the contractor did not pay him was because he was an immigrant and less likely to take legal action. CLA filed a complaint in Circuit Court against the contractor and the contractor soon agreed to pay \$20,000 to Mr. M to settle the case.







With client fees only covering 17% of our operational expenses, support from our donors allows CLA to continue to provide affordable legal services to those who otherwise would be priced out of the legal market.





### **KEEPING FAMILIES TOGETHER WITH HALOS**

Ms. L. was referred to CLA from HALOS. She was seeking custody of her minor arandchild because of DSS involvement with the grandchild's maternal arandfather. The Client's dauahter passed away in 2015 and her grandchild went to live with his grandfather. The grandfather was mentally unstable and the child was hurt while under his care. DSS agreed that it was in the best interest of the child to live with our Client. CLA helped Ms. L navigate the family court and the custody process. We were able to get the grandfather to sign over custody and our client's grandson is now living with her, safely.

In March 2021, CLA entered into a partnership with HALOS, a nonprofit organization that provides services to kinship families, to ensure kinship caregivers have access to legal counsel and services regarding custody of their kinship children.

Since we started the HALOS partnership, CLA has assisted 25 caregivers with their legal matters.

"Without [CLA], those boys wouldn't have a chance. They would still be shuffling around through DSS. Our two blessings have been Charleston Legal Access and HALOS." - Mrs. N

# COMMUNITY INVOLVEMENT

### PREVENTING HOMELESSNESS THROUGH HOUSING COURT

Charleston Legal Access was selected as a host organization for the Equal Justice Works' Housing Justice Program and as a subgrantee of a HUD award issued as part of its Eviction Protection Grant Program. CLA's selection to participate in these programs marks a crucial victory in its effort to combat the worsening housing crisis and prevent homelessness in the Tri-county area by providing legal services to low-income tenants at risk of or facing eviction and expanding Housing Court to Berkeley and Dorchester counties.

Given the exceptionally high risk of eviction in these counties, accessible legal representation is needed now more than ever. Currently, in South Carolina, a staggering 99.7% of tenants are not represented in eviction cases, mainly due to the high costs or complicated steps involved in getting an attorney. CLA hopes to eliminate these barriers by continuing the expansion of the Housing Court.

### MY SISTER`S HOUSE PARTNERSHIP
